stronger. The College's PharmD
program has officially been granted the
maximum eight year continued
accreditation!

The program, students, staff and faculty were all highly praised by the site team and that praise was reiterated in the final Actions and Recommendations (A&R) report

approved by the ACPE Board.

Yes, there are several areas cited by ACPE that we need to address, but we are at a strong point in the program.

With the success comes more work. All Colleges of Pharmacy are faced with implementing the new accreditation standards that were approved in January 2015 (See page 3). And there are the updated CAPE objectives to deal with also. So yes, we've been successful, but as always, there is more

to do.

Our College is completing our internal review of the HSCI program. An external review team will visit this March to provide an outside perspective of the program. Some summary data on the success of the HSCI program is highlighted in this addition and is just a sample of what the reviewers will see. There is plenty to be proud of with the HSCI program.







Scholarship Trends:


The College continues to advance scholarship- one aspect of its mission. In 2014, the College received over \$442,000 in new grants! This is a significant increase over the previous two years and does not include multi-year grants initiated in previous years and running through 2014. Faculty also oversaw 36 student research projects and had students cited on abstracts and publications 40 times.

In 2014 alone, the College faculty produced over **126** peer and non-peer reviewed scholarly works. This includes <u>58 podium presentations</u>, <u>34 posters</u>, <u>and 34 articles</u>. HSCI Review by the Numbers

- 136 Number of student graduating from the HSCI program from 2012 to 2014
- 83% HSCI graduates placed in employment positions or pursuing additional education since 2012
- 25 Number of sites used in 2014 for senior capstone experiences
- 77% HSCI graduates who said their capstone confirmed their chosen career path
- 93% HSCI graduates who said they had opportunities to engage in active learning
- 80% HSCI alumni who said they'd still choose Drake if starting their HSCI education over again
- 83% Retention rate of HSCI students at Drake University

Improvement: The internal review of the HSCI program has identified several areas to address in the 10 year plan. These include: strengthening and better integration of the "Issues 1-5" course sequence; improved advising through realigning assignments and mandatory meetings; earlier mentoring of capstone projects; creation of a national advisory council; as well as branding enhancements that could include a research track in the program and opportunities in the curriculum to gain CAN and PT Assistant credentials.
