The program will continue to grow and stretch on this objective with the goal of continuing to prepare and graduate students capable of

These results are certainly a mixed bag with respect to how well the program is meeting this objective. As noted below the concerns with KPI 4 career development will be addressed in multiple classes. Some program changes have been started and will take some time to impact outcomes. The performance on KPIs 5 and 7 are in line with expectations. The data suggest that students are developing a solid foundation of counseling skills and are able to translate this into sessions but the specific area of career counseling and career development warrants additional attention. Efforts in the upcoming year will address this concern.

# Student Dispositions

The Counseling Program began measuring and monitoring student dispositions in 2015 tracking six different dispositions across different classes. A complex matrix noted which disposition was measured in each class. The program sought to simplify and focus the disposition evaluation system. The faculty were also concerned about cultural implications of some of the previous dispositions. Specifically, *professionalism*, which was defined as 'attire fitting to setting', has been described as a social construct that reinforces oppression, particularly sexism, racism, and classism (Gray, 2019; Manthey, 2017; Negrete-Lopez et al., 2020; Rios, 2015). The review resulted in a new evaluation system of three dispositions, described below, which are rated by all instructors at the conclusion of each course. This process provides consistent and continual evaluation for all students.

Students are rated by instructors on a three-point system from 1 deficient, 2 marginal, and 3 meets. Students are then provided feedback through Starfish a campus wide advising platform. In addition to end of course ratings the ongoing surveys from program graduates and site-supervisors as well as annual surveys of employers provide another opportunity to gather information on dispositions. At the program level mean scores for each disposition are monitored across term as well as in courses where the ratings are highest and lowest. The faculty then review and discuss any curricular or program changes that might be undertaken in response to this data. Disposition information is also monitored over time to track any longitudinal changes. The new dispositions were implemented for the fall 2021 term so it will take several semesters before longitudinal data is available.

- Creation of the Tools of Analysis assignment in the COUN 221 Methods course to facilitate students ability to identify systemic oppression in counseling sessions and utilize theory to identify new ways of responding that acknowledge oppression.
- New preparation activities and introduction of an assessment thesaurus in the COUN 224 Assessment course to prepare students to utilize assessment tools.
- Feminist development model was integrated into the COUN 225 Human Development course to broaden students' perspectives.

#### Action Items for the 2022-2023 Academic Year

- Monitor item 7 in the COUN 260 Practicum end of class supervisor evaluation related to students articulating knowledge of biological, psychological, social, and cultural factors related to counseling. If ratings do not demonstrate improvement the faculty will adjust teaching in relevant courses.
- New instruction on writing session narratives for the COUN 291 Clinical Mental Health Counseling Internship.
- Monitor site supervisor and employer ratings related to student demonstration of case conceptualization skills. This area of emphasis has improved in coursework but has not yet translated to employers' perceptions of student performance.
- Program faculty will meet over the summer 22 term to review and devise strategies to address concerns in the career development KPI 4 as well as KPI 8 related to critique and utilization of research.
- Program faculty will continue to integrate sociocultural context into lifespan development. Decolonization of developmental research readings will be added in the Human Development course.
- The Practicum and Internship coordinator will reach out to site supervisors and employers to explore their specific expectations with respect to career development and career counseling so expectations can be integrated into program instruction.
- Readings on evidence based and evidence informed interventions will be integrated into the Research course. Program faculty will develop a checklist of critiquing and selecting research informed and based interventions.
- Rehabilitation Counseling program faculty will reach out to internship site supervisors, alumni, and employers to collect feedback on the key components of rehabilitation clinical case presentations to ensure students are acquiring and demonstrating knowledge, skills, and abilities critical to the workforce.
- Rehabilitation Counseling program faculty will continue to collect student, practicum/internship supervisor, alumni, employer, and advisory board feedback about the Clinical Rehabilitation Counseling and Rehabilitation Counseling KPIs so that a stronger assessment (larger number of students assessed) of the program's ability to meet the KPIs can be performed.

# **Program Evaluation Conclusions**

- The program is meeting or exceeding benchmarks for 57 of the 71 items in the KPIs for which data is available in the past year
- The program is clearly meeting stated objectives for four program objectives multicultural and social justice, advocacy, school counseling, clinical mental health counseling.

- The program is mostly meeting stated objectives in the areas of professional and ethical as well as biologically, psychological, and social. The program has specific plans to address items not meeting benchmarks in these areas.
- Student dispositions continue to be clearly documented with overwhelming data that students are demonstrating appropriate development of reflection, openness, and commitment.
- The program will focus on collecting data to evaluate the rehabilitation counseling and clinical rehabilitation counseling specialization in the upcoming year.
