In October we tabled a course change until we could ask clarifying questions.

Michael Renner's answers to questions asked by Council re PSY024/BIO025.

Did both Psychology and Biology approve the course change?

Yes, both departments discussed and approved at their respective department meetings.

Without prerequisites, will students register that shouldn't, taking seats from students who should?

We have been using the "major restriction" mechanism to hold enough seats for students who need this specific course. By working with Alina Grimm to estimate the number, we have gotten pretty close the last couple of semesters. I welcome other students into the course on a space available basis, and there are always a few.

How will this course change affect other courses in the department?

In the direct sense, it won't have an impact. Both Psych 1 and Bio 13 are still required for students in the Zoo and Animal Behavior concentrations, and this change would only affect sequencing, i.e., how soon after matriculating the students would be able to take Animal Behavior. We're not proposing that Animal Behavior take the place of any course for other students, or be allowed to play a role in the curriculum that it doesn't currently play, so cascading effects don't seem very likely. Of course it's always possible that there will be unexpected consequences, but I've tried to imagine indirect and secondary effects and haven't ... uh .. anticipated any.

Part of this change is essentially a retention tool. If a student comes to Drake to study animal behavior, making them wait until they're sophomores to get into the first course is a great way to frustrate them. And, because the multiple pathways into the course leave at least part of the class needing to cover necessary foundational concepts anyway, it's an unnecessary frustration. As the application said, I am experimenting with waiving the prerequisites this semester, and so almost half of the class are firsts-year students. Their average midterm grades were higher than those of the rest of the class. This is a confounded experiment because the incoming Zoo & Conservation Science students are a high-ability group (mean ACT of 30), but whatever the explanation, the students don't seem hampered by not having taken the prerequisites!

The reasoning behind the current prerequisites, I think, was that students need some background in behavioral science or ecology and evolution, but not necessary both, to succeed. In theory, this is fine. In practice, it just doesn't work.

Because some students will have had Psych 001 and others haven't, the instructor has to at least touch on basic psychological concepts; when I teach the course, for example, I cover Pavlovian and instrumental learning from the beginning because those things surface everywhere. Similarly, because some students will have had Bio 13 and other haven't, the instructor ends up covering evolution and at least some of the basic ecological concepts. So, at the bottom line, these prerequisites aren't actually accomplishing much.

Also, unless they carry in AP credits, Psych majors are at least second semester, and Biology students are at least second year before they can get into Animal Behavior. Especially for those interested in the field, this is frustrating to them.

But, it is still effectively our department's phenomenology and existentialism course. So, since I won't be using the old title any longer, our department would like to change the title permanently to "Existential Films."

Current Course Description

Contemporary continental philosophy is home to vibrant discussions about ethics, politics, art, life, and the meaning of the human experience. These contemporary discussions have their roots in the fields of existentialism and phenomenology, and in the work of scholars from the nineteenth and twentieth centuries such as Nietzsche, Heidegger, Sartre, and Levinas. This class will not only help you to learn about phenomenology and existentialism from a historical perspective but will encourage you to consider the relevance of these philosophies to daily life. Prereq: at least one PHIL course or consent of instructor.

New Course Description

Explore the meaning of life through films as well as readings in existential philosophy. This class will investigate questions about personal identity, fate and human freedom, moral relativism and universal truth, and finding fulfillment in life through readings by philosophers from a variety of world cultures.
