## <u>Drake Law School Hosts Supreme Court Banquet Featuring Chief Justice Susan</u> Christensen

Drake University Law School will host its annual Supreme Court Celebration from April 2-5, 2025, highlighting the school's strong connection to the judiciary and its commitment to legal education.

The celebration will culminate in the Supreme Court Celebration Banquet on Friday, April 5, held in Parents Hall at the Olmsted Center. The evening begins with a reception at 6 p.m., followed by dinner at 7 p.m.

This year's keynote speaker is Chief Justice Susan Christensen of the Iowa Supreme Court. Chief Justice Christensen, who has served on the court since 2018 and as Chief Justice since 2020, will share her thoughts and perspectives during the Banquet. Learn more about it here.

## <u>Drake Public Safety carries Naloxone (Narcan)</u>

Naloxone (Narcan) can potentially save someone's life by reversing the effects of an Opioid emergency, such as Fentanyl. Drake Public Safety (DPS) carry Narcan when patrolling campus, and their typical response time is 2-3 minutes. In addition, Narcan dispensary kits are now available in all residence halls and at Olmstead Center Student Services. DPS can be contacted 24/7 by calling 515-271-2222.

#### **ADA** accommodation renewal

Remember that accommodations must be renewed annually! To establish or renew accommodations under the Americans with Disabilities Act (ADA), contact the <u>Office of Access and Success</u> for an appointment. This should be done at least three (3) business days before the event and/or prior to entering into a rental contract. If food is served, you will also need to get your order to Sodexo at least one week prior to the event to avoid late fees.

## **Contagious Illness Protocols**

Although reporting is no longer required, infectious students cannot attend in-person classes and must contact their instructors to coordinate making up any missed material. Faculty may use their own discretion for how to treat absences due to illness.
