# Discuss options for 2022-2023 academic calendar

- Concern for 13-day J-term; rules indicate J-term should be 14-days
- To run a 3-hour credit course in 14 days is difficult, so 13-days is a problem. We may need to look at creative options. Could we add 1 credit in fall?
  - Does J-term need to be a 3-credit course? No, there are 1, 2, 3, and 4-credit J-term courses.
- What if we extend J-term to Monday, Jan. 16, and start semester on Tuesday, Jan. 17?
  - This is a problem for those classes that meet only on Monday. The classes would lose that whole first week of the semester.
- Teach on Saturday or start early.
  - o On-campus classes cannot start before J-term begins on Jan. 3. Could we meet before the winter break? In December finals week? That is against the rules.
  - o Away time is already over extending time and energy. To try and make up the time on the Saturday in the middle of the trip would be overwhelming.
- Is it 14 days or is it hours? The guidelines say 14 days, but can the credit hour guideline be met in 13 days?.
- Why is Jan. 2 or Martin Luther King, Jr., Day off limits when you are abroad?
  - o A Jan. 2 start would mean that staff have to work on Jan. 1, a holiday, to get the buildings open.

- o If you work one of these days, then could the staff take a floating day off?
- Federal Laws affect this.
- o These are more of an issue with on-campus classes.
- Could we relax the rules about meeting on campus and staying in the dorms? Most of our students could come to Des Moines and have a place to stay for a day before we leave.
  - This is an equity issue: It penalizes those who do not have a place to stay. It is also risk mitigation issue.
- Could you use an online option for the preparation days? For these odd 13-day J-term years, do a day or two online.
- For 3 credits you need to meet from 9-12, 5-days per week: Just add 15-minutes per day and it's covered.
- This is an issue for those who travel. With our travel days and time differences, it is already hard to find meeting spaces to fulfill hours.
- J-terms range from 13 to 17 days, based on the calendar year. It is not just hours in the day.
- Maybe just look ahead, and if it's a 13-day J-term, teach a 2 credit class that year.
- Prep work before we go is the issue, so as an institution, why can't we meet in December finals week?
  - o We can't do it final week, but we can do it on class days
- Could we use Dead Day?
  - o Rules say that we cannot meet on Dead Day: no mandatory class meetings. Jenny Tran-Johnson will see what the rule actually says.
- In the past, when teaching a short J-term, we did our prep work in the fall, evening times. Then in January, we were ready to travel.
- Some of the courses fulfill AOI requirements.
- If this is on the December agenda, will senators be ready to vote? Consensus agreed.
