Policy Summary: Prohibits hazing in any form and outlines prevention, reporting, and

accountability measures.

# **Policy Summary**

This policy prohibits hazing at Drake University and provides guidelines for prevention, reporting, and enforcement.

#### **Purpose**

To establish a safe and inclusive environment by aligning with The Stop Campus Hazing Act, Iowa Code § 708.10, and Drake University's Code of Student Conduct, and to outline measures for hazing prevention, response, and accountability.

### Scope

This policy applies to all Drake University students, faculty, staff, and student organizations, both on and off campus. There are no exclusions.

#### **Definitions**

Hazing is defined as any intentional, knowing, or reckless act—occurring on or off campus—committed by one or more persons, whether affiliated with a student organization or not, against a student for the purpose of recruitment, initiation, affiliation, admission, or continued membership in a group or organization. This includes acts that may cause physical harm, mental distress, embarrassment, harassment, or put the student at risk of injury, regardless of consent.

### **Policy**

Drake University strictly prohibits hazing in all forms. In accordance with The Stop Campus Hazing Act and Iowa Code § 708.10, all students, faculty, staff, and affiliated organizations are expected to uphold a culture of respect and safety. Reports of hazing can be submitted confidentially to the Dean of Students Office, Drake Public Safety, the Des Moines Police Department, or anonymously via EthicsPoint. Retaliation against good faith reporters is prohibited. Violators may face university discipline and/or criminal prosecution subject to applicable state, federal and/or sanctions within the <a href="Code of Student Conduct">Code of Student Conduct</a>.
